Preparation instructions

Preheat oven to 220°C. Remove all packaging and place the deep-frozen pizza directly in the middle of the oven on a furnace grate (for a crispy crust) or on a baking plate (for a soft crust) and bake for 8 to 10 minutes for conventional oven (6 to 8 minutes for ventilated oven).

Store at -18°C. Once defrosted do not refreeze.
